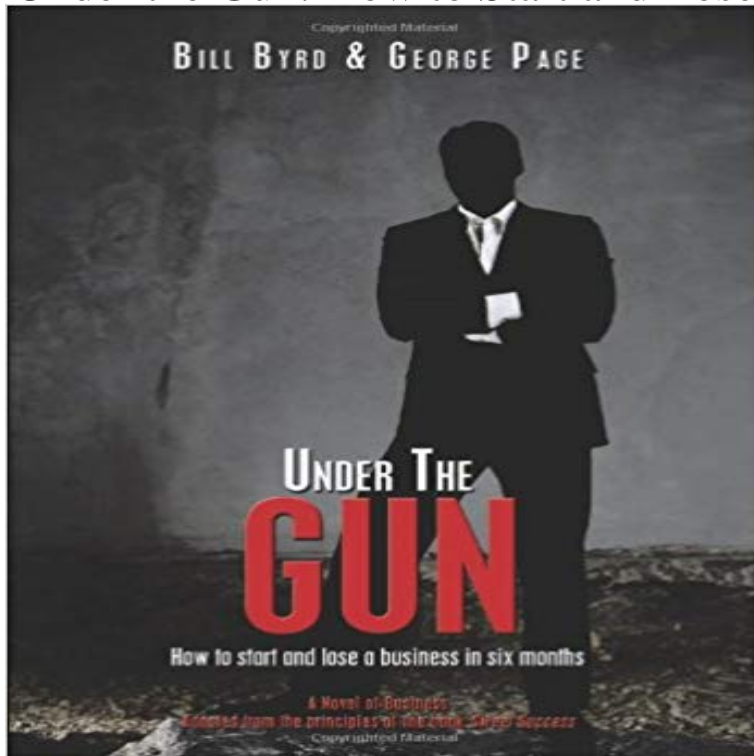


Under the Gun: How to Start and Lose a Business in Six Months
