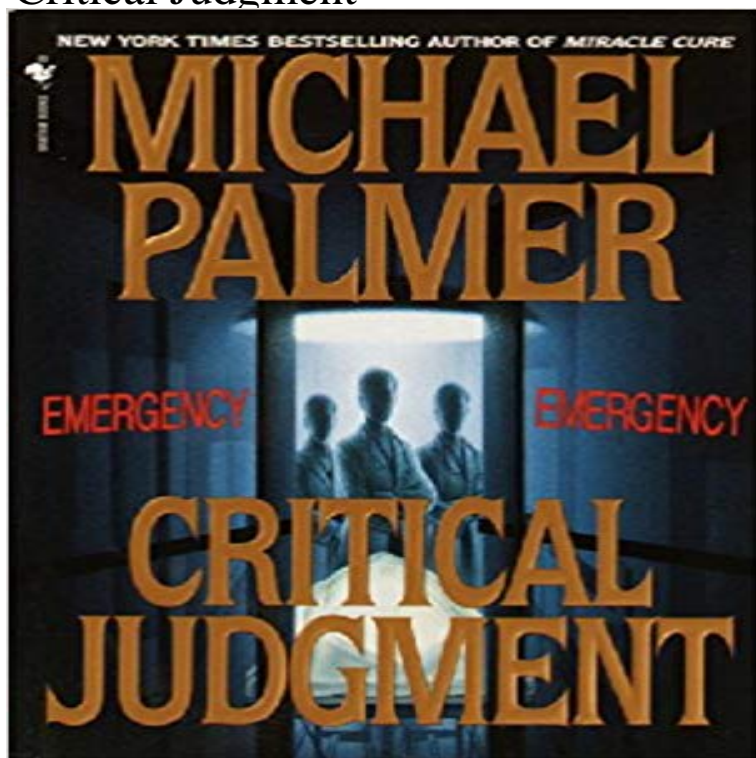


Critical Judgment
