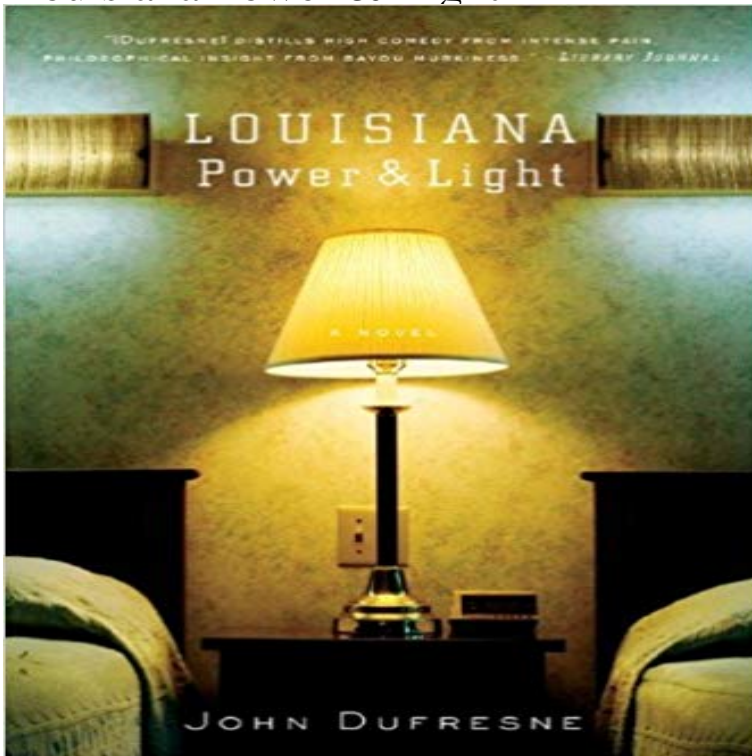


## Louisiana Power & Light
