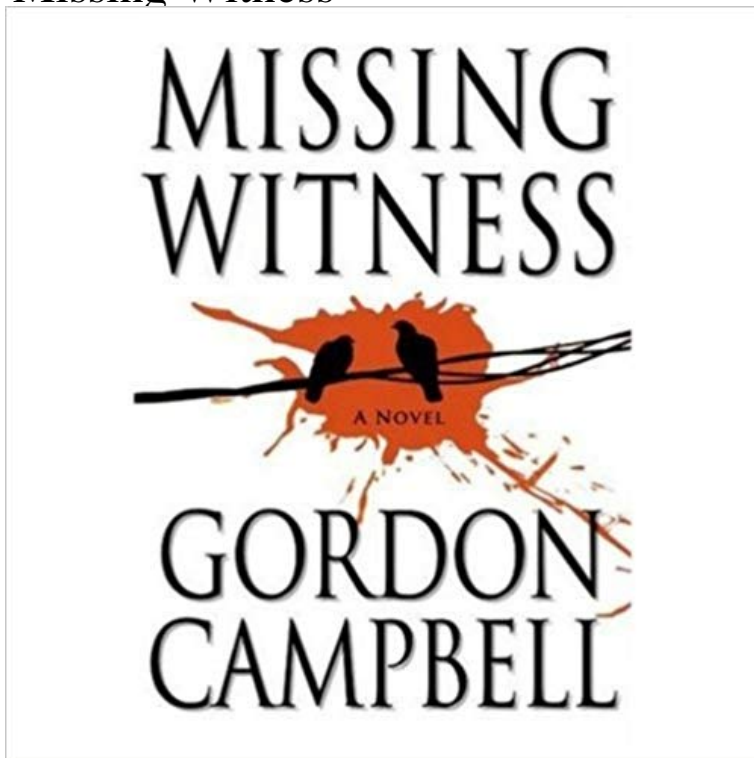


Missing Witness
