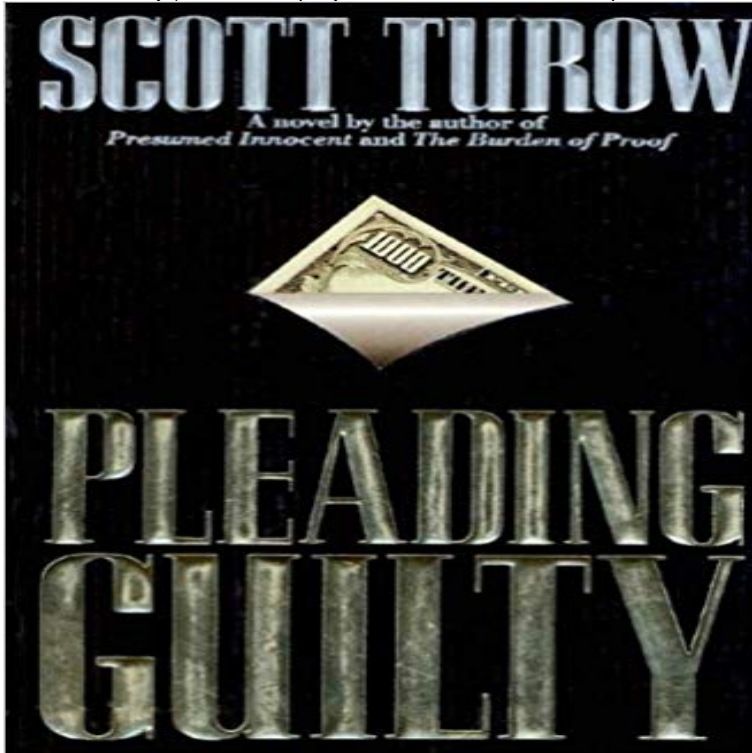


Pleading Guilty (Kindle County Book 3)
