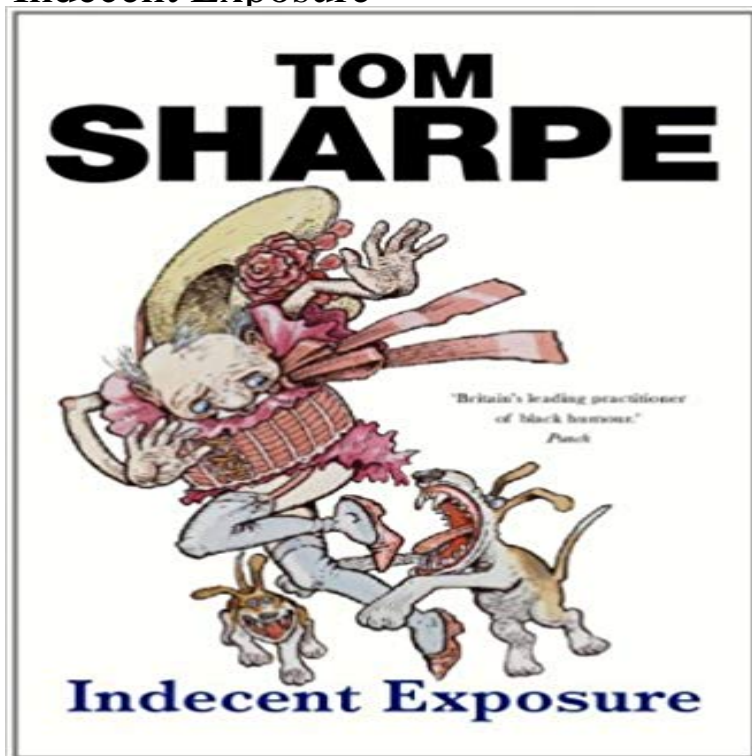


Indecent Exposure
