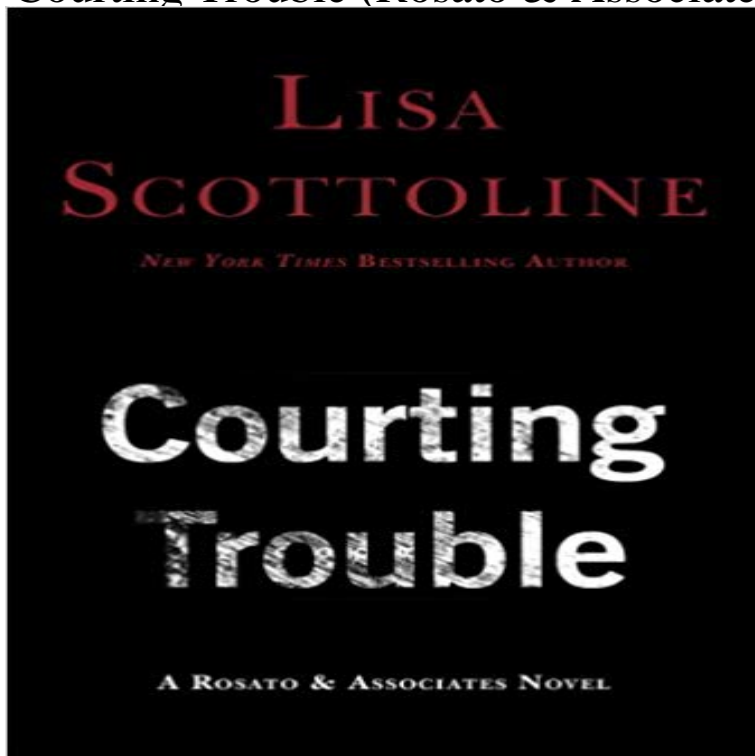


Courting Trouble (Rosato & Associates Book 7)
