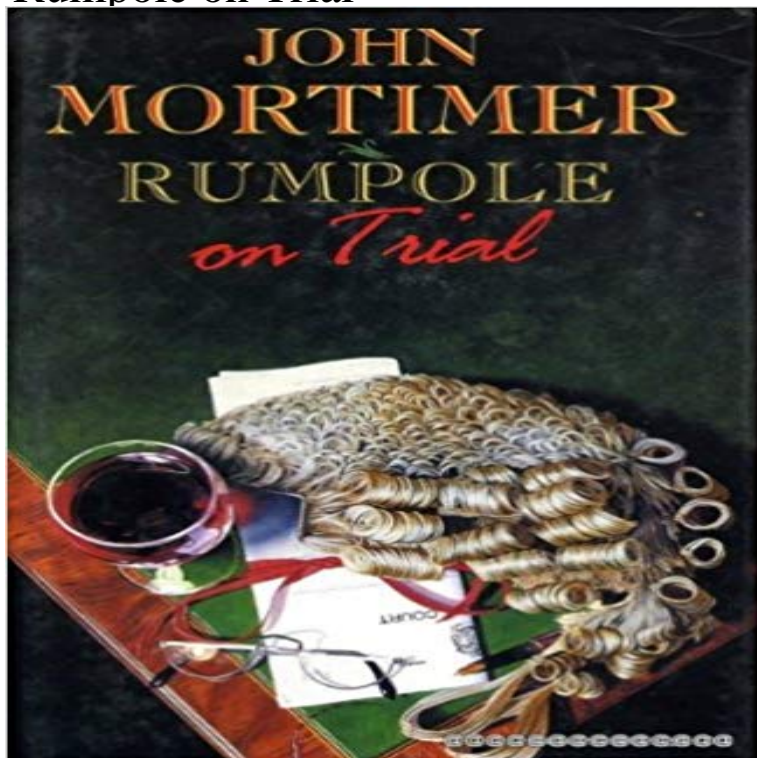


Rumpole on Trial
