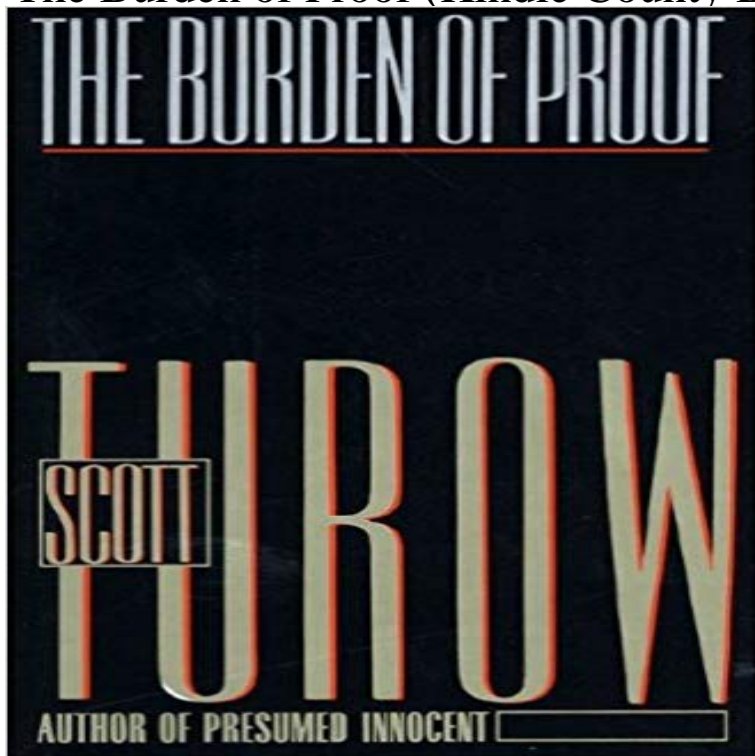


## The Burden of Proof (Kindle County Book 2)
