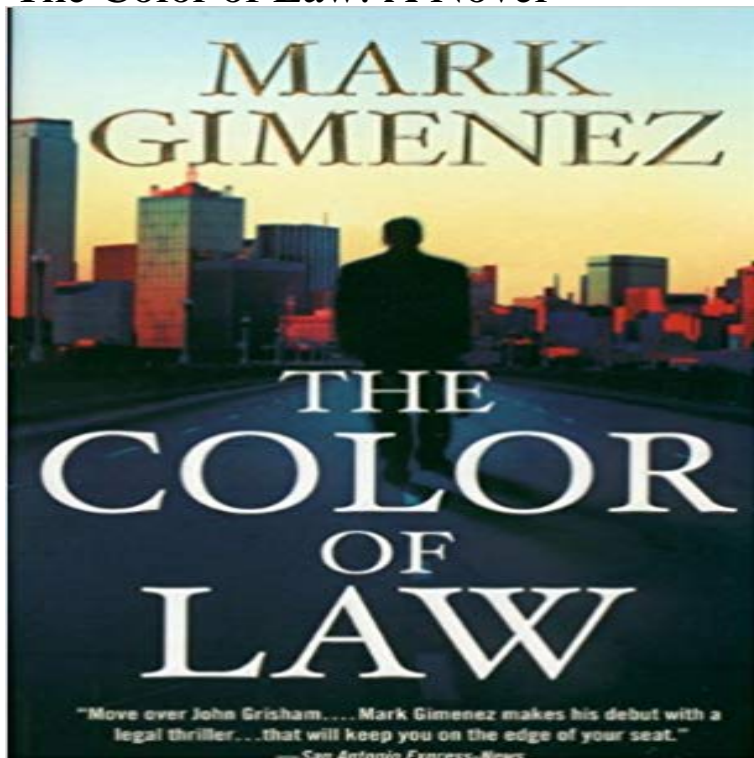


## The Color of Law: A Novel
