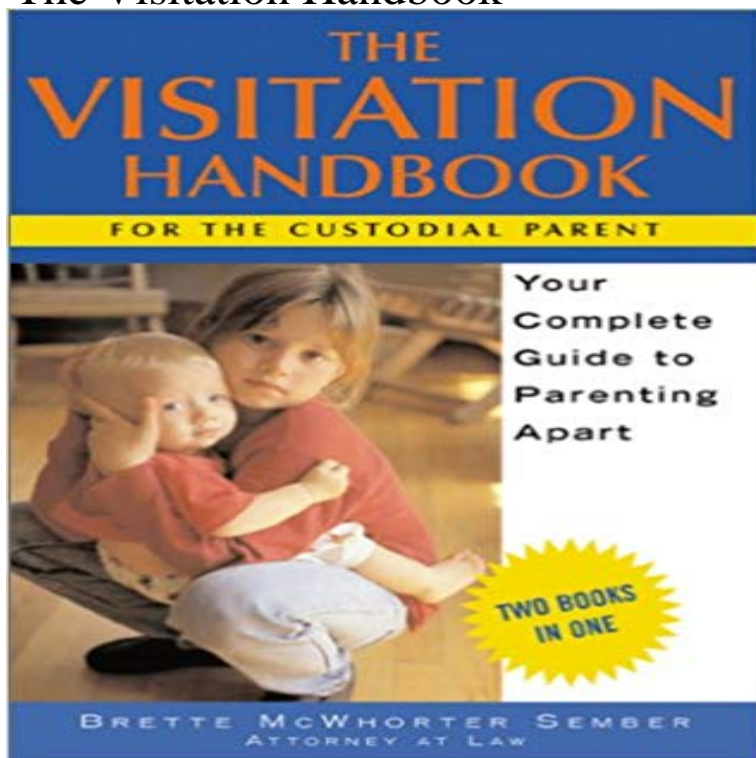


## The Visitation Handbook
